Follow these steps to meet Indonesia's requirements **for toys**

To distribute and sell toys in Indonesia, international and domestic manufacturers, as well as importers, must demonstrate, through testing and certification, that they are compliant with the **Indonesian National Standards** (Standar Nasional Indonesia, **SNI**) and EN 71-5 for phthalates.

In addition, all compliant toys must display the Indonesian National Standard Certification Mark, the SNI Mark.

General requirements

In Indonesia [Regulation Number 24/M-IND/PER/4/2013](#) and its amendments cover toy safety. This law applies to the following list of toys, with their harmonized system (HS) tariff codes.

1	Baby walkers	9403.70.10
2	Tricycles, scooters, pedal cars and similar wheeled toys, and doll carriages	9503.00.10
3	Dolls	9503.00.21
4	Electric trains, including tracks, signals and other accessories	9503.00.30
5	Reduced size (scale) models and similar recreational models, whether working or not	9503.00.40
6	Other construction sets and constructional toys manufactured from materials other than plastics	9503.00.50
7	Stuffed toys representing animals or non-humans	9503.00.60
8	Puzzles of every type	9503.00.70

9	Numerical, alphabetical or animal blocks or cut outs, word builder sets, word making and talking sets, toy printing sets, toy countingframes (abaci), toy sewing machines, and toy typewriters	9503.00.91
10	Skipping ropes	9503.00.92
11	Marbles	9503.00.93
12	Other toys, made from rubber	9503.00.94
13	Toys other than items 2 to 12 above, made from all kinds of material, whether or not electrically operated: <ul style="list-style-type: none"> • Balloons, swimming floats for children or other inflatable toys made of rubber and/or plastic • Toy rifles or toy gun • Other toys 	9503.00.99

Table 1: Toys, by type, requiring SNI certification and labeling

Toys destined for Indonesia must:

- Conform to all relevant mandatory SNI standards and EN 71-5
- If compliant, apply for product certification and display the SNI Mark

SNI standard and SNI Mark program

SNI standard

The scope of toy products is detailed in Table 1, and the applicable methods which our lab has capability for, are summarized in Table 2.

SNI Mark

Toy certification can only be obtained by application to the certification body **Lembaga Sertifikasi Produk (LSPro)**, appointed by the Minister of Industry.

- LSPro processes certification applications, verifies documentation and obtains test results from a laboratory that has been approved by the Minister of Industry
- On successful completion of a product assessment, the Indonesian manufacturer or importer will receive certification
- Once SNI approval has been granted, the Indonesian manufacturer or importer must place the SNI Mark on the product and/or its packaging
