TRADE SINGLE WINDOW

Commonly known as a Regulatory or National Single Window (NSW) solution, this service is key to digitizing and orchestrating the regulatory processes and procedures related to international and cross border trade. Encompassing features like processing and electronically issuing trade licenses, permits and certifications, interfacing closely with the Customs backend system, it provides a one-stop-shop for stakeholders to exchange information electronically, from the declaration request to the release of goods.

INTERNATIONAL MARITIME ORGANIZATION (IMO) MARITIME SINGLE WINDOW

The Maritime Single Window (MSW) extends the reach of the digital information exchange between ship and shore to logistics players and port community stakeholders.

This platform also supports IMO (FAL) compendium reporting. It is common for the MSW to integrate or exchange information with the NSW.

PORT COMMUNITY SYSTEM

The Port Community System (PCS) that we offer focuses on supporting B2B activities and transactions within the port/terminal operation. Our vision of PCS will facilitate service requests between private stakeholders, and record the services rendered and associated fees.

To improve business reporting, the platform includes an integrated invoicing and payment module. In a typical scenario, integration with MSW and/or NSW is expected.

CUSTOMS MANAGEMENT SYSTEM

The Customs Management System (CMS) is used by Customs to support their day-to-day operations. It supports electronic submission of declarations and manifest filing, and provides the ability to capture the entire process of goods' arrival to their release. Other modules, such as valuation, risk management, selectivity, auction management, warehouse management and post audit clearance can also be managed within the system.

RISK MANAGEMENT SYSTEM

We have access to a state-of-the-art Risk Management System (RMS) that aligns with the WCO Risks Compendium processes. The RMS can be integrated seamlessly with the CMS and NSW as an extended function to monitor risky transactions. Customs authorities or border agencies can define and customize risks and establish actionable steps on each risk scenario captured. An Artificial Intelligence (AI) algorithm can also be introduced.
