## WHICH PRODUCTS FALL WITHIN SCOPE?

As of November 1, 2021, the following products require a SIRC certificate:

- Electric pumps (5 hp or less)
- Mobile phones
- Mobile phone chargers
- Car chargers for mobile devices
- Wireless chargers for mobile phones
- Mobile phone batteries
- Power banks
- Laptops and tablet devices
- Chargers for tablet
- Smart watches/smart band
- TVs and monitors
- Dishwashers (for household use)
- Wireless headphones
- Laptop chargers/Power adapters
- PV products (PV panels, inverters, PV electric cables)

- Lighting products (lamps, control gears, luminaires)
- Electronic cigarettes
- Electric kettles
- Coffeemakers (for household use)
- Deep fryers
- Electric cables
- Video game consoles and accessories
- Shavers
- Desktop computers
- Miniature circuit breakers
- Molded case circuit breakers
- Mobile phone charger cables



### WHAT DOCUMENTATION IS REQUIRED FOR A SIRC?

You will need a number of documents for each EE product. We can help you identify and collate all the correct documentation, which could include:

- Manufacturer industrial license
- Valid Commercial Registration of SA importer (issued by the Saudi Ministry of Commerce and Industry (MOCI))
- Letter of undertaking and acknowledgment (see attached template), which must be completed and signed by an authorized person, printed on the manufacturer's letterhead with a company stamp
- Product photo
- Manufacturer Declaration of Conformity (see attached template), which must be completed and signed by an authorized person, printed on the manufacturer's letterhead with a company stamp. The "Manufacturer" is the manufacturer mentioned in the CB test certificate/CB test report
- Importer Declaration of Conformity (see attached template), which must be completed and signed by an authorized person, printed on the manufacturer's letterhead with a company stamp
- Instruction Manual in English and Arabic, including details of the brand and model/s
- IECEE CB Test Report original test report, plus amendment/modification test reports according to the latest IEC standard, including Saudi Arabia specifications
- IECEE CB test certificate (IECEE CBTC) according to the latest IEC standard and issued by a laboratory operating under the IECEE CB scheme (original test certificate plus amendment/modification test certificate)
- PLUG Test Report according to SASO 2203:2018 (for electrical and electronic appliances with Plug for connection to mains supply)
- EEL CERTIFICATE for lighting products
- CITC Certificate for mobile phones
- Authorization letter to SGS (as the facilitator on behalf of the applicant)
